- 5) Conduct which constitutes a criminal offence where that conduct –
  - a. Took place on or in the vicinity of SRI CHAITANYA premises or
  - b. Affected or concerned other members of the SRI CHAITANYA, or
  - c. Damage or threatens the reputation of the SRI CHAITANYA or
  - d. Itself constitutes misconduct within the meaning of these Rules, or
- 6) Damage to or wrongful treatment of the property or equipment of the SRI CHAITANYA or any of its staff, students or visitors or any action likely to cause injury to any person or impairing the health and safety of the premises or its occupants.
- 7) Action or omission, which could cause loss, damage or injury or put others at risk.
